- 4. Under the Single Envelope Procedure, Bidders are required to submit electronic biding containing Technical Bid and Financial Bid at once.
- 5. Pre-bid meeting shall be held at office of Nepal Insurance Regulatory Authority, Lalitpur-10, Kupandole, Nepal at 14.00 o'clock of 30th June 2024.
- Electronic bids must be submitted to the office of Nepal Insurance Authority through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12.00 Noon of 9th July 2024. Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14.00 PM of 9th July 2024 at the office of Nepal Insurance Authority, Lalitpur-10, Kupandole, Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the Bank guarantee for bid security in pdf format amounting to a minimum of NRs 336,000/which shall be valid for 30 days beyond the validity period of the bid.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
